Get your leading edge in ESG

ESG is of increasing importance in Australia – and has become a core strategic concern across almost all sectors. ESG is not a "nice to have" but an imperative of mutual and co-operative business.

The BCCM has trailblazed the discussion about how co-operatives and mutuals can leverage their 'mutual advantage' in the era of ESG. After our groundbreaking Sustainability Summit in 2021, the BCCM has now successfully run the ESG Mutual Business Program in both 2022 and 2023.

The third edition of the ESG Mutual Business Program will focus on environmental, social and governance issues from the unique perspective of co-operatives and mutuals. The program brings co-operatives and mutuals up to date with the current and near-future ESG impacts and regulation, via six expert-led workshops and the first ever one-day in-person symposium in Perth in October 2024 (to run concurrently with the BCCM Leaders' Summit).

You will learn from experts about the latest ESG trends, and network with other co-operative and mutual organisations on their ESG journey. Sessions will cover:

- Interpreting and planning for current and upcoming mandatory ESG disclosure requirements including the new Australian Sustainability Disclosure Standards (ASDS)
- Supporting participants to develop sustainability and impact reports what a good report looks like in the mutual sector
- Reviewing ESG frameworks, accreditations and standards which ones add value for co-ops and mutuals
- Evolving your sustainability/ESG strategy so that it resonates with members, boards and your communities and builds a more sustainable and resilient business

Workshops



WORKSHOP 1 Strategy

This workshop will help you to identify your co-op or mutual's unique strengths and opportunities in ESG, develop a compelling ESG narrative tailored to your co-op or mutual, and learn strategies for building boardroom buy-in for sustainability initiatives.



WORKSHOP 2

ESG accreditations and impact

This workshop will provide you with an overview of key ESG frameworks, accreditations, and standards, and help you to select the right ones for your co-operative or mutual. You will also hear from an international speaker with a real case study example.



WORKSHOP 3

Preparing for reporting


This workshop will cover the Australian Sustainability Reporting Standards (ASRS) and their implications for co-operatives and mutuals. You will also learn about ISSB Standards and current and upcoming requirements.



WORKSHOP 4

Avoiding greenwashing

This workshop will cover how you can effectively communicate your message as a co-op or mutual without greenwashing. You will also learn how to comply with ACCC, ASIC, and international guidelines. Plus, there will be an international speaker and a case study.



WORKSHOP 5

Latest on ESG reporting

This workshop will build on Workshop 3, focusing on developing exemplar sustainability reports and the role of mutual value measurement in sustainability reporting.



WORKSHOP 6

Resilience, transition, transformation

This workshop will bring all of the learning from the previous workshops together and help you deliver on sustainability challenges – green skills and future–proofing your co–op or mutual. You will also have the opportunity to network with other participants, share your experiences and listen to an international speaker.



One-day ESG and Sustainability Symposium: Perth, October 2024

A one-day, in-person symposium exploring ESG and sustainability for the co-operative and mutual sector. This program is a first for Australia and will include:

- Additional speakers and presentations around key ESG topics and case studies
- Collaboration workshops including an 'ESG clinic' working together with peers on common challenges
- Presentation of case studies
- Network with peers and make new contacts
- Cost includes dinner with symposium participants

The ESG program demonstrates the importance of sharing stories and information that bridge the gap between different organisations' sustainability journeys.
