Together, these discussions will highlight the sector's strategic relevance and the steps needed to embed co-ops and mutuals more deeply in public policy, business and community life.

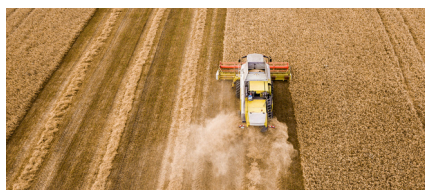
